Food Vendor Information General Information & Conditions

- Art in the Park is held at Hoopes Park in Auburn, New York. Located at Genesee Street (Rte 20) and South Herman Ave.
- The cost for Food Vendor space is \$40 before August 1st, \$50 after.
- There is no accessible electricity. Vendor truck or booth must be self-reliant. Generators should be a “low volume” model.
- The event & venue does not provide tables & chairs for dining.
- Weather is out of our control. THERE IS NO RAIN DATE – The event is held rain or shine. Be prepared for inclement weather.
- We strive to prevent competition for like menus. Food vendors are limited to the menu presented at the time of application. Any additions or changes must be approved prior to the event.
- Location assignments will be provided at check-in.
- All trash and debris must be taken with you upon departure.
- Food Vendors are responsible for any permits, licensing, sales tax, etc... that complies with governmental rules & regulations.
- Certificate of insurance required with registration.
